

RESOLUTION NO. 508

BY THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES.

WHEREAS, the City of El Paso de Robles did acquire certain properties in the City of El Paso de Robles by Sheriff's deeds through the years 1926 to 1928 inclusive under foreclosure proceedings for delinquent assessment liens pursuant to an act of the Legislature of the State of California, entitled "Improvement Bond Act of 1915", and

WHEREAS, since title to said property being vested in the name of the City of El Paso de Robles, a Municipal Corporation, there has been no tax revenues realized either to the City of El Paso de Robles or the County of San Luis Obispo, and

WHEREAS, at the time of acquisition of said properties by the City of El Paso de Robles there were County tax liens standing against them and still remaining unpaid according to County records, and

WHEREAS, the City Council of the City of El Paso de Robles desires that said tax liens be cancelled.

THEREFORE, BE IT RESOLVED by the City Council of the City of El Paso de Robles that the City Clerk of the City of El Paso de Robles be and he is hereby instructed to request the Board of Supervisors of the County of San Luis Obispo, California to cancel all uncollected taxes, penalties and costs heretofore levied on said properties hereinafter referred to and described as follows:
