

RESOLUTION NO. 535

DECLARING AND STATING THE RESULT OF
CITY ELECTION HELD APRIL 9th, 1946

BE IT AND THE SAME IS HEREBY RESOLVED by the City Council of the City of El Paso de Robles, meeting at their usual place of meeting on the 16th day of April, 1946, pursuant to the Elections Code No. 9918;

That whereas, a general municipal election was held and conducted in the City of El Paso de Robles, County of San Luis Obispo, State of California, on Tuesday, the 9th day of April, 1946 and,

Whereas the same was held as required by law and,

Whereas the City Council of the City of El Paso de Robles at this meeting, pursuant to the Elections Code No. 9918, have canvassed the returns of said election and have found that the number of votes cast in the city, the names of the persons voted for, the offices for which each person voted for, the number of votes given at each precinct to each person, the number of votes given in the city to each person, and the results of said election to be as hereinafter stated;

NOW THEREFORE be it and the same is hereby further resolved that said election was held and conducted in said City of El Paso de Robles, County of San Luis Obispo, State of California, on Tuesday, the 9th day of April, 1946, at the time and in the manner provided by law and that there were two voting precincts established for holding said election, one of which was designated as Precinct A and was comprised of the regular election precincts established for the holding of general County and State elections and known as Paso Robles No. 1, Paso Robles No. 2, Paso Robles No. 3, and Paso Robles No. 5; and other said precincts was designated as Precinct B

and was comprised of the regular election precincts established for the holding of general County and State elections and known as Paso Robles No. 4, Paso Robles No. 6, Paso Robles No. 7, and Paso Robles No. 8.

BE IT FURTHER RESOLVED that the whole number of votes cast in said election was 636.

That the names of the persons voted for, the number of votes given at each precinct to each person and the number of votes given in the City to each person are as follows:



