Each probationary salary adjustment for patrolmen and officers shall be made only on written recommendation by the Chief of Police.


Common Labor 1.00 per hour

BE IT FURTHER RESOLVED that the salary rates and schedules as established herein shall become effective as of August 1, 1949 and any payment heretofore made on any salary after the first day of August, 1949, shall be adjusted on a retroactive basis from said date to all present employees in their respective salary brackets.

BE IT FURTHER RESOLVED that the City Council may amend any salary schedule listed of established salaries for any new positions not listed herein by duly passed motion made with reference to this resolution.
