

RESOLUTION NO. 668

RESOLUTION ORDERING SIDEWALK AND GUTTER IMPROVEMENT  
ON VINE STREET BETWEEN FOURTH STREET AND TENTH STREET.

WHEREAS, the City Council of the City of El Paso de Robles did on the 6th day of June, 1949, pass its resolution of intention No. 656 to order the hereinafter described work to be done and improvements to be made in said City, which resolution of intention was fully and legally published as required by law, as appears from the affidavit of Thomas J. Barry now on file in the office of the City Clerk of said City; and

WHEREAS, notices of passage of said resolution of intention No. 656, headed "Notice of Improvement", were duly and legally posted along the lines of said contemplated work and improvement therein referred to and along each of the streets mentioned in said resolution, and in front of all the property liable to be assessed for such work and improvements, in form and manner as required by law, after the passage of said resolution of intention, as appears from the affidavit of L. N. Payne, who personally posted the same, said L. N. Payne then being the superintendent of streets of said City of El Paso de Robles, who after the completion of the posting of said notices, filed his affidavit in the office of the city clerk of said city, making oath that he completed the posting of said notices on the 11th day of July, 1949; and

WHEREAS, all protests and objections to said work or improvements or the the grades at which the same is to be done have been heard, overruled and disposed of and said city council has now acquired jurisdiction to order the proposed work and improvement.

THEREFORE, BE IT RESOLVED by said City Council that that the public interest and convenience require the work described in said resolution of intention No. 656 and said City Council does hereby order the work to be done and the improvements to be made with reference being made to said resolution of intention for further particulars.

That the said City Clerk is hereby directed to post a notice of said work, together with the plans and specifications therefor,

conspicuously for five (5) days on or near the council chamber door of said city council, inviting sealed proposals or bids for doing the work ordered. He is also directed to publish twice in the Paso Robles Press, a semi-weekly newspaper of general circulation printed, published and circulated in said City of El Paso de Robles, and hereby designated by said City Council for that purpose, a notice inviting such sealed proposals and referring to the specifications posted or on file.

That all proposals or bids offered shall be accompanied by a Cashiers Check, Certified Check, or Cash for an amount which shall not be less than ten (10) per cent of the aggregate of the proposal, or by a bond for the said amount and so payable, signed by the bidder and two sureties, who shall justify before any officer competent to administer an oath, in double the said amount and over and above all statutory exemptions.

That sealed proposals or bids shall be delivered to the clerk of said City Council, to-wit: the said City Clerk, on or before five o'clock P. M., on Monday, the 31st day of October, 1949, said time being not less than ten days from the time of the first publication and posting of said notice. Bids will be opened on said day at the hour of 8 o'clock P. M.
