RESOLUTION MAKING APPLICATION TO DEPARTMENT OF FINANCE.

WHEREAS, The State of California under Chapter 47, Statutes of 1944 (4th Extra Session), has appropriated funds for allotment by the Director of Finance to provide for financial assistance to Local Agencies defined therein as counties, cities or cities and counties for the purpose of defraying not to exceed one-half the cost of preparing engineering field surveys, engineering or architectural designs, and working and detailed drawings and specifications (hereinafter called "Plans") required for postwar public works projects described as "specific projects" in said Act; and

whereas, The City of El Paso de Robles, hereinafter designated as "Local Agency", desires to apply to the Director of Finance and/or the State Allocation Board, as the case may be, for an allotment of the balance of the State's share of the total cost of preparing the completed plans hereinafter mentioned and which have been prepared and presented to this legislative body for consideration; and

WHEREAS, Local Agency has provided sufficient funds to prepare the completed plans herein mentioned; now, therefore, be it

RESOLVED, That local agency submit the aforesaid application to the Director of Finance and/or the State Allocation Board, as the came may be, requesting supplemental allotment of Seven Hundred Thirty Four and 62/100 Dollars (\$734.62) being a balance of Threee Thousand Six Hundred Ninty and 94/100 Dollars (\$3,690.94) which sum is not more then one-half the cost of preparing said completed plans for a speific project to be undertaken by local agency and described as "Construction of Sewage Treatment Plant", be it further

RESOLVED, That the total cost of preparing such plans was **Eaght** Thousand Six Hundred Twenty Six and 24/100 Dollars (\$8,626.24) and that local agency has made provision for paying one-half or more of the cost of preparing such plans; be it further

RESOLVED, That for the purpose of this application, S. S. Tucker, City Clerk, 723 Thirteenth Street, Paso Robles, California,

be and he hereby is designated as the authorized agent of local agency and he is hereby authorized and directed to sign the above-mentioned application on behal of the local agency and submit the same to the Director of Finance and/or the State Allocation Board together with a certified statement of the total cost of preparing such plans and other information required; and said authorized agent is further authorized and directed as the representative of local agency to conduct all negotiations and conclude all arrangements, including submission to the Director of Finance of applications for reimbursement, which may be necessary to secure reimbursement for the State's share of the expenditures made in preparing said completed plans.
