

RESOLUTION NO. 742

RESOLUTION OF THE CITY OF EL PASO DE ROBLES FOR
ANNEXATION OF CERTAIN UNINHABITED LAND TO THE CITY OF EL
PASO DE ROBLES, GIVING NOTICE OF TIME AND PLACE OF THE
HEARING.

WHEREAS, a petition has heretofore been filed on or about the 21st day of August, 1951, requesting the annexation of the uninhabited territory known as Villa Lot 52 of the City of El Paso de Robles; and

WHEREAS, the Planning Commission on the 10th day of September, 1951, recommended the annexation of Villa Lot 52 by the City of El Paso de Robles; and

WHEREAS, the written petition is signed by owners of not less than one-fourth of the land in the territory by area and by assessed value as shown on the last equalized assessment roll of the County of San Luis Obispo; and

WHEREAS, the territory hereinafter described is unincorporated and is uninhabited pursuant to the provisions of the uninhabited territory act of 1939 and by Part 2, Chapter I, Article 5 of the Government Code, and is contiguous to the Westerly boundary of the City of El Paso de Robles;

NOW, THEREFORE, the City Council of the City of El Paso de Robles does resolve as follows:

RESOLVED, that the within described territory is uninhabited and lies contiguous to the Westerly City Limits of the City of El Paso de Robles and is situate in the County of San Luis Obispo, State of California; and is particularly described as follows:

All of Villa Lot 52 of the City of El Paso de Robles, in the County of San Luis Obispo, State of California, according to map of the City of El Paso de Robles and adjacent lands, filed for record on October 25, 1889, in the office of the County Recorder of San Luis Obispo County, State of California.

That the foregoing territory shall hereafter be

known and designated as "Annexation for Villa Lot 52"; that Monday, October 22nd, 1951, at the hour of 7:30 P. M. of said date, in the Council Chamber of the City Hall, in the City of El Paso de Robles, County of San Luis Obispo, State of California, is the time and place when and where any person owning real property within such territory so proposed to be annexed and having any objections to the proposed annexation, may appear before the City Council of the City of El Paso de Robles and show cause why such territory should not be annexed to the City of El Paso de Robles and be included and incorporated therein.

RESOLVED FURTHER, that at any time not later than said hour set for hearing objections to the proposed annexation, any owner of property within the territory proposed to be annexed, may file a written protest against the proposed annexation which protest shall state the name or names of the owner or owners of the property affected thereby and the description and area of such property.


RESOLVED FURTHER, that the City Clerk of the City of El Paso de Robles be and he is hereby directed to cause a copy of this Resolution to be published at least once a week for the three weeks prior to the hearing, in the Paso Robles Press, a newspaper of general circulation, published and circulated in the City of El Paso de Robles.

RESOLVED FURTHER, that the City Clerk be and he is hereby directed to mail a postcard to the owners of all property within said Villa Lot 52 as shown on the latest equalized assessment roll of the County of San Luis Obispo, State of California.


