

RESOLUTION NO. 751

OF INTENTION TO ACQUIRE AND/OR CONSTRUCT
IMPROVEMENTS

SPRING STREET CURBS AND GUTTERS
PROJECT NO. 51-1

RESOLVED, by the City Council of the City of El Paso de Robles, California, that in its opinion the public interest and convenience require, and that it is the intention of said City Council to order the following acquisitions and/or improvements to be made, to-wit:

1. The acquisition and construction or acquisition or construction of Portland cement concrete monolithic standard curbs with 2 foot gutters on each side of Spring Street between First Street and Ninth Street and between Twentieth Street and Thirty-Eighth Street, and all work auxiliary thereto necessary to complete the same.

2. All of said work and improvements are to be constructed at the places and in the particular locations, of the forms, sizes, dimensions and materials, and at the lines, grades and elevations, as shown and delineated upon the plans, profiles and specifications to be made therefor, as hereinafter provided.

3. There is to be excepted from the work above described any of such work already done to line and grade, and marked excepted or shown not to be done on said plans, profiles and specifications.

4. Said City Council does hereby adopt and establish as the official grades for said work the grades and elevations to be shown upon said plans, profiles and specifications. All such grades and elevations are to be in feet and decimals thereof with reference to the datum plane of the City of El Paso de Robles.

5. Notice is hereby given of the fact that in many cases said work and improvements will bring the finished grade to a grade

different from that formerly existing, and that to said extent said grades are hereby changed and that said work will be done to said changed grades.

6. The estimated cost of said project is \$55,000.00, of which \$38,407.23 will be assessed upon the benefited properties and the balance will be contributed by the City.

7. Said contemplated acquisitions and/or improvements, in the opinion of said Council, are of more than local or ordinary public benefit, and said Council does hereby make the expense of said acquisitions and/or improvements chargeable upon a district, which district said Council declares to be the district benefited by said acquisitions and/or improvements and to be assessed to pay the costs and expenses thereof, the exterior boundaries of which are the coterminous exterior boundaries of the lots, pieces or parcels of land abutting on the portions of Spring Street to be improved between First Street and Ninth Street and between Twentieth Street and Thirty-eighth Street, and Spring Street for its full width between First Street and Thirty-eighth Street.

8. Notice is hereby given that serial bonds to represent the unpaid assessments, and bear interest at the rate of not to exceed five per cent (5%) per annum, will be issued hereunder in the manner provided by the Refunding Assessment Bond Act of 1935 as modified in the Municipal Improvement Act of 1913, the last installment of such bonds shall mature nine (9) years from the second day of July next succeeding ten months from their date.

9. Except as herein otherwise provided for the issuance of bonds, all the work above mentioned shall be done pursuant to the provisions of the Municipal Improvement Act of 1913, as amended.

(b) Maps and descriptions of the lands and easements to be acquired herein;

(c) Engineer's estimate of the itemized and total estimated costs and expenses of said acquisitions and/or improvements and of the incidental expenses in connection therewith:

(d) Diagram showing the assessment district above referred to and also the boundaries and dimensions of the respective subdivisions of land within said assessment district as the same existed at the time of the passage of this Resolution of Intention, each of which subdivisions shall be given a separate number upon said diagram;

(e) A proposed assessment of the total amount of the costs and expenses of the proposed acquisitions and/or improvements upon the several subdivisions of land in said assessment district in proportion to the estimated benefits to be received by such subdivisions, respectively, from said acquisitions and/or improvements, and of the expenses incidental thereto.

14. If any excess shall be realized from the assessment it shall be spent for the maintenance of said acquisitions and/or improvements, unless the Council shall hereafter determine that said amount or any part thereof shall be applied as a credit to each assessment herein.


