## RESOLUTION NO. 752

## OF PRELIMINARY APPROVAL OF ENGINEER'S REPORT SPRING STREET CURBS AND GUTTERS PROJECT NO. 51-1

RESOLVED, by the City Council of the City of El Paso de Robles, California, that

WHEREAS, on the 3rd day of December, 1951, said City Council did adopt its Resolution of Intention No. 75/to construct street improvements in said city, and did refer the proposed improvement to the City Engineer of said City, he being the officer having charge and control of the construction of public improvements in and for said City of the kind described therein, and being a competent person employed by said City for that purpose, and did therein direct said City Engineer to make and file with the City Clerk of the said City, a report in writing all as therein more particularly described, under and pursuant to the Municipal Improvement Act of 1913, as amended;

WHEREAS, said City Engineer has made and filed with the City Clerk of said City, a report in writing as called for in said Resolution of Intention, and under and pursuant to said Act, which report has been presented to this Council for consideration;

WHEREAS, said City Council has duly considered said report and each and every part thereof, and finds that each and every part of said report is sufficient, and that said report, nor any part thereof requires or should be modified in any respect;

NOW, THEREFORE, IT IS ORDERED, as follows:

1. That the plans and specifications for the proposed improvements to be acquired and/or constructed, contained in said report, be and they are hereby, preliminarily approved and confirmed;

- 2. That the Engineer's estimate of the itemized and total estimated costs and expenses of said acquisitions and/or improvements and of the incidental expenses in connection therewith, contained in said report, be, and each of them are hereby, preliminarily approved and confirmed;
- 3. That the diagram showing the assessment district referred to and described in said Resolution of Intention, and also the bondaries and dimensions of the respective subdivisions of land within said District as the same existed at the time of the passage of said Resolution of Intention, each of which subdivisions having been given a separate number upon said diagram, as contained in said report, be, and it is hereby, preliminarily approved and confirmed;
- 4. That the proposed assessments upon the several subdivisions of land in said Assessment District in proportion to the estimated benefits to be received by such subdivisions, respectively, from said acquisitions and/or improvements, and of the incidental expenses thereto, contained in said report, be, and they are hereby, preliminarily approved and confirmed;
- 5. That said report shall stand as the City Engineer's report for the purpose of all subsequent proceedings had pursuant to said Resolution of Intention.
