

RESOLUTION NO. 769

DECLARING THE RESULT OF THE REGULAR  
MUNICIPAL ELECTION HELD April 8, 1952.

BE IT AND IT IS HEREBY RESOLVED by the City Council of the City of El Paso de Robles, in session at their regular meeting place this 15th day of April, 1952, pursuant to the Elections Code under Section No. 9918:

THAT WHEREAS, a general municipal election was held and conducted in the City of El Paso de Robles, County of San Luis Obispo, State of California, on Tuesday, the 8th day of April, 1952, and

WHEREAS, said election was held and conducted in said City at the time and in the manner provided by law and that there were two voting precincts established for holding said election, one of which was designated as Precinct "A" and was comprised of the regular election precincts established for the holding of general County and State elections and known as Paso Robles No.1, Paso Robles No.3, Paso Robles No.4 and Paso Robles No.6 and the other precinct being designated as Precinct "B" and was comprised of the regular election precincts established for the holding of general County and State elections and known as Paso Robles No.2, Paso Robles No.5, Paso Robles No.7 and Paso Robles No.8, and

WHEREAS, the City Council of the City of El Paso de Robles at this meeting having canvassed the returns of said election and found that the number of votes cast in said City, the names of the persons voted for, the offices for which each person was voted for, the number of votes given at each precinct to each person, the number of votes given in the City to each person, and the results of said election to be as hereinafter stated:

That the whole number of votes cast in said election was 1069.


