## RESOLUTION NO. 771

## APPLICATION FOR EXTENSION OF TIME FOR BEGINNING CONSTRUCTION ON SITE OF SEVAGE DISPOSAL PLANT UNDER CHAPTER 47, STATUTES OF 1944 (4th Extra Session) as amended

1. WHEREAS, the State of California, under Chapter 47, Statutes of 1944 (4th Extra Session), as amended, appropriated funds to provide financial assistance to local agencies defined therein as counties, cities and counties, or cities of the State of California in the acquisition of rights-of-way and sites for postwar public works; and

2. "HEREAS, the City of El Paso de Robles, hereinafter called ("Local Agency", requested aid under Chapter 47, Statutes of 1944 (4th Extra Session), as amended, which request is identified as Request No. 47/2121, and was allotted, under Allotnent No. A-115, the sum of One Thousand Seven Hundred Eighteen and Sixty three One Hundredths Dollars (\$1718.63), by the State of California on November 12, 1948, in connection with the acquisition of site described as "24.58 acres on the North City Limit" for the purpose of constructing thereon Sewage Disposal Plant, as approved by the State allocation Board; and

3. WHEREAS, Section 24 of said Chapter 47 provides that if Local Agency sells or otherwise disposes of a site acquired under the Act, or does not begin to use the site for the purpose or purposes as approved by the State Allocation Board within five years after the acquisition was completed, then the Director of Finance shall demand the return by the Local Agency of the total amount advanced by the State; and

4. MHEREAS, said section 24 further provided that on application by the local Agency, the State Allocation Board may notify the Director and the Local Agency that the time to begin use of the site for the approved purpose or purposes is extended beyond five years, specifying the period and any conditions of the ex-

tension, and in such case the Director shall not make said demand until expiration of the extension; and

5. WHEREAS, Local Agency acquired said site on April 30, 1947 and to date has not made use of same for the purpose pr purposes approved; and

6. WHEREAS, expiration of the five year period within which
Local Agency must begin to use the above-stated site is Abril 30,
1952 and Local Agency desires to apply to the State Allocation Board
for extension of time for use of this site for the following reason:

The City of El Paso de Robles has applied to the Federal Government for emergency funds in the amount of \$200,000.00 for the purpose of constructing a new sevage disposal plant on the subject site, which work is expected to commence during the next fiscal year.

7. NOW, THEREFORE, BE IN RESOLVED, that the Local Agency, pursuant to the provisions of Chapter 47, Statutes of 1944 (4th Extra Session), as amended, submit this resolution to the State Allocation Board, making application for extending to April 30, 1955, the time within which Local Agency must begin to use the site for the purpose or purposes approved by the State Allocation Board.
