RESOLUTION NO. 774

REQUESTING CONSENT OF THE COUNTY OF SAN LUIS OBISPO TO ORDER THE CONSTRUCTION OF A SANITARY SEWERAGE SYSTEM AND TO PROVIDE THAT THE COSTS THEREOF SHALL BE ASSESSED ON A SPECIAL DISTRICT UNDER APPROPRIATE SPECIAL ASSESSMENT AND ASSESSMENT BOND ACTS

CRESTON ROAD TRUNK SEWER

RESOLVED, by the City Council of the City of Faso Robles, California, that

WHEREAS, it is the intention of this Council to undertake proceedings pursuant to appropriate special assessment and assessment bond acts for the acquisition and construction of the following improvements:

- (a) The construction of a 10-inch diameter vitrified clay sewer main with wye branches and standard manholes complete in Creston Road between the west side of River Road and a point about 1500 feet easterly thereof;
- (b) The construction of sewage pumping station complete at the junction of River Road and State Highway No. 41;
- (c) The construction of a 8-inch diameter cast iron sewage pressure line in State Highway No. 41 from River Road to Riverside Avenue;
- (d) The doing of all work and the acquisition of all lands and easements auxiliary to any of said work and necessary to complete the same;

whereas, it is the intention of this Council to levy and collect assessments and issue and sell bonds against the properties contained within the boundaries of the assessment district, the exterior boundaries of which are the coterminous exterior boundaries of the composite and consolidated area consisting of Capitol Hill Tract, Lots 1 thru 12, Orchard Bungalow Tract, Moore Park Tract, Adobe Hill Ranch, unsubdivided portion of Lot 13 lying westerly of Orchard Bungalow

that all of the provisions of the specifications to be adopted by the City Council of said City be complied with to the end that no greater amount of ditches are opened at any time that is necessary, that they shall be adequately lighted and barricaded, that they shall be promptly backfilled, and that said streets shall be restored with materials of like quality and character as those existing therein at the time of such work.

- 3. That said proposed proceedings be had pursuant to a resolution of intention substantially in conformity with the form thereof a copy of which is hereto attached and made a part hereof.
- 4. That the City Clerk of this City be, and he is hereby directed to file with the County Clerk a certified copy of this resolution, together with a copy of said proposed resolution of intention.
