

RESOLUTION NO. 1650

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES,  
CALIFORNIA, REQUESTING THE RELEASE OF 2400 ACRE FEET OF WATER  
FROM THE SALINAS DAM DURING 1972.

WHEREAS, the City of El Paso de Robles holds Permit No. 8471 which requires the release of 2400 acre feet of water from the Salinas Reservoir annually; and

WHEREAS, it is vitally important to the welfare of the community that this water be released annually; and

WHEREAS, this water is required to flush out the contaminants of the River and to fill the pocketed aquifers with water for domestic purposes; and

WHEREAS, if the River is not flushed with this amount of water and the aquifers replenished, the health, safety and welfare of the residents of Paso Robles, and the area as a whole, will be jeopardized; and

WHEREAS, the waters of the Salinas Reservoir must provide water for the peoples in the Salinas Valley for their welfare and economic growth; and

WHEREAS, for like reasons, the 200 acre feet to which they are entitled should be released to each of the Districts, Santa Margarita, Templeton District No. 6, and San Miguel; and

WHEREAS, these commitments must be fulfilled prior to any water being diverted out of the Salinas Valley; and

WHEREAS, a copy of this Resolution will be sent to the U. S. Corps of Engineers, the State of California Water Rights Board, and the San Luis Obispo County Hydraulic Engineer, requesting the release of these waters into the Valley to assure an adequate supply of water to the peoples of the Valley; and

WHEREAS, the release of these waters shall commence during the month of April 1972 and continue thereafter until the said amounts have been delivered to the Salinas Valley; and


WHEREAS, the City of El Paso de Robles is ready and willing to pay for the 2400 acre feet of water to be released as required by Permit No. 8471.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of El Paso de Robles respectfully requests that the 2400 acre feet of water be released from the Salinas Reservoir as required under said Permit No. 8471 into the Salinas River to safeguard the domestic water supply of the City of El Paso de Robles, commencing April 1, 1972, and continuing thereafter until said amount has been released; and, further, that 200 acre feet of water shall be released into the Salinas River from said Dam for each of the Districts, Santa Margarita, Templeton District No. 6, and San Miguel, during this same period.
