

RESOLUTION NO. 1654

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES, CALIFORNIA, FURNISHING ASSURANCES AS TO THE STATUS OF RIGHTS OF WAY PERTAINING TO TOPICS PROJECT NO. T-3058(2), and AGREEMENT THAT THE STATE OF CALIFORNIA SHALL BE HELD HARMLESS FROM LIABILITY AS TO SAID RIGHTS OF WAY CLEARANCES.

WHEREAS, the City of El Paso de Robles has agreed to the construction by the State of California Division of Highways of Traffic Signals at the intersections of 12th and 13th Streets and Spring Street, under TOPICS PROJECT NO. T-3058(2); and

WHEREAS, all rights of way for the construction of this Project are within the limits of the rights of way of the above streets; and

WHEREAS, no utility poles or appurtenances are scheduled to be moved, except as shown on the plans; and

WHEREAS, the signs at the Shell and Standard Service Stations at 12th and Spring Streets will be relocated; and

WHEREAS, there are no other known obstructions; and

WHEREAS, compliance with the provisions of IM-80-1-68 is not required for this Project.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of El Paso de Robles that the City of El Paso de Robles agrees to hold the State of California harmless from any liability that may result in the event the rights of way are not clear as certified; and, if the State is named in a damage suit, as a result of the rights of way not being clear as certified, the City of El Paso de Robles will, at the request of State, assume full responsibility for the conduct of the defense or provide such assistance as the State may require and will pay any Judgments issued against the State and all costs in connection with the defense.


