

RESOLUTION NO. 1669

A RESOLUTION OF INTENTION FOR VACATING AND CLOSING
AN ALLEY IN THE CITY OF EL PASO DE ROBLES AND GIVING
NOTICE OF TIME AND PLACE FOR A PUBLIC HEARING THEREON

THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES does hereby resolve as follows:

1. That it is the intention of the City Council to close and vacate for street purposes an alley, all within the City of El Paso de Robles, County of San Luis Obispo, State of California, and more particularly described as follows;

All of that certain portion of the alley that lies between Lot 27, Lot 28 and a portion of Lot 29 as said alley and Lots are shown on the "D.S. Gregory's Subdivision of Riverside Farm No. 2", map filed for record May 8, 1888 in Map Book "B", Page 17 in the office of the County Recorder of San Luis Obispo County, State of California.

2. For further particulars as to the proposed vacation, reference is hereby made to a map and plan now on file in the office of the City Clerk of the City of El Paso de Robles.

3. That in the event of said closing, as hereby and above described, the City of El Paso de Robles will reserve a permanent easement for the installation, maintenance, repair or replacement of utility and drainage facilities within the closed alley.

4. That Monday, July 17, 1972, at the hour of 8:00 P.M. on said date in the City Council Chambers, City Hall, Paso Robles, California, is the time and place set forth for hearing all persons interested in or having objections to the proposed closing.



That the City Clerk of the City of El Paso de Robles be and he is hereby directed to cause a copy of this Resolution of Intention to be published ten days prior to the date set herein for hearing in the Paso Robles Daily Press, a newspaper of general circulation, published and circulated in the City of El Paso de Robles, California.

6. The Director of Public Works of the City of El Paso de Robles be and he is hereby directed to cause a notice of the passage of this Resolution of Intention and the time and place set for hearing thereon by conspicuously posting notices thereof along the line of the alley purposed to be closed and vacated.


