

RESOLUTION NO. 1691

A RESOLUTION BY THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES REQUESTING THE BOARD OF SUPERVISORS OF THE COUNTY OF SAN LUIS OBISPO TO CANCEL TAXES ON CITY OWNED PROPERTIES

WHEREAS, the following properties of the City of El Paso de Robles have been purchased and/or deeded to the City;

1. Water Well Field Site - known as Thunderbird Well Site
County Assessors Parcel No. 40-091-28 & 40-031-22
2. Paso Robles Area Pioneer Museum Site - Riverside Avenue
and Gregory Street - County Assessor Parcel No. 08-261-03
3. Solid Waste Disposal Site - County Assessor Parcel Nos.
15-041-33 & 15-041-38

and;

WHEREAS, all properties, hereunder, are within the incorporated City limits of said City; and

WHEREAS, said property was acquired by the City of El Paso de Robles for domestic water well and supply system, an historical museum, and Solid Waste Disposal, and because of these public uses and ownership they are not subject to County Taxes; and

WHEREAS, said property was assessed upon the 1971-72 and the 1972-73 County Tax Rolls with taxes thereon not paid.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of El Paso de Robles, that the City Clerk of said City be, and he is hereby directed, to forward a Certified Copy of this Resolution to the Board of Supervisors of the County of San Luis Obispo as a request to order the Tax Collector of said County to cancel all uncollected taxes, penalties and costs heretofore levied upon the above described properties and any assessment being placed on for future tax purposes.
