

RESOLUTION NO. 1697

A RESOLUTION REQUESTING THAT AIR WEST  
RE-ESTABLISH MORNING FLIGHTS

WHEREAS, AIR WEST formerly provided morning weekday flights to and from San Francisco and Los Angeles (flights from Paso Robles to San Francisco at 9:50 daily and from San Francisco to Paso Robles at 8:15 daily and from Paso Robles to Los Angeles at 9:15 daily and from Los Angeles to Paso Robles at 8:00 daily); and

WHEREAS, said morning flights have been terminated and there are now afternoon flights (from Paso Robles to San Francisco at 2:45 daily and from San Francisco to Paso Robles at 12:10 daily and from Paso Robles to Los Angeles at 1:15 daily and from Los Angeles to Paso Robles at 1:15 daily); and

WHEREAS, the ticket office of AIR WEST was formerly open during the morning hours and now opens at 11:00 A.M.; and

WHEREAS, the morning flights were of substantial benefit to businessmen going to or coming from the major metropolitan areas of San Francisco and Los Angeles; and

WHEREAS, the late afternoon flights are substantially less convenient and preclude a full work day with return in the evening and have the effect of requiring in some instances an overnight stay and will necessarily decrease air travel on AIR WEST between Paso Robles and the major metropolitan areas of San Francisco and Los Angeles;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES AS FOLLOWS:

That the City Council of the City of El Paso de Robles registers its opposition to such change in schedule,

that the original schedule be re-established,  
authorizes the Mayor, City Clerk and City Staff to  
take appropriate steps to secure the re-establishment  
of the original schedule.
