hereby accepted and the City of El Paso de Robles consents

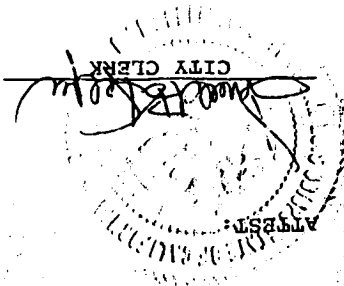
to recordation of said Grant of Easement by its duly

## ROAD DESCRIPTION

A 60 foot road whose centerline is described as follows:

beginning at the intersection of the west line of the East Half of Section 18, Township 26 South, Range 13 East, M.D.M., and the north line of Dry Creek Road, a 50 foot County Road; thence along the north line of said Dry Creek Road S 75° 26' 25" E, 80.94 feet to the True Point of Beginning; thence N 14° 33' 35" E, 125.00 feet; thence along a curve to the right whose radius is 350.00 feet, through a central angle of 34° 22' 39", for an arc length of 210.00 feet; thence along a reverse curve whose radius is 450.00 feet, through a central angle of 38° 50' 02", for an arc length of 305.00 feet; thence N 10° 06' 12" E, 595.00 feet; thence along a curve to the left whose radius is 1,800.00 feet, through a central angle of 31° 49' 52", for an arc length of 1,000.00 feet; thence along a compound curve whose radius is 300.00 feet, through a central angle of 53° 10' 04", for an arc length of 278.39 feet; thence along a reverse curve whose radius is 300.00 feet; through a central angle of 41° 12' 28", for an arc length of 215.76 to a point on the west line of the East Half of said Section 18.


