

RESOLUTION NO. 2569

A RESOLUTION CLOSING PORTIONS OF A STREET IN THE
CITY OF EL PASO DE ROBLES

WHEREAS, the City Council of the City of El Paso de Robles, having on the 7th day of April, 1981 passed a Resolution of Intention to vacate for street purposes, all within the City of El Paso de Robles, County of San Luis Obispo, State of California, and more particularly described as follows:

A portion of Lot 12 of Bennet and Bailey's Subdivision of part of Deer Park in the City of El Paso de Robles, County of San Luis Obispo, State of California according to map recorded in Book A, Page 115 of Maps, in the office of the County Recorder of said county, being all of that portion of said Lot 12 lying within that certain easement for road dedication described in deed recorded in Book 1299, pages 506 through 509 of official records of said county lying easterly of the following described line:

Beginning at the most northerly corner of Lot 11 of aforesaid Bennett and Bailey's Subdivision of a part of Deer Park, thence southerly along that westerly line of said Lot 11 shown as having a bearing of N3-30 W to it's southerly terminus, said terminus being the true point of beginning of this description; thence S30-19-44W 65.00 feet; thence S-45-00 E to an intersection with the easterly line of that aforesaid road dedication described in said deed recorded in Book 1299, pages 506 through 509 of official records.

WHEREAS, it now appears that the City Clerk of the City of El Paso de Robles did cause said Resolution of Intention to be published in the Paso Robles Daily Press as required by law; and

WHEREAS, it also appears that the Director of Public Works for the City of El Paso de Robles did cause notices to be posted along said alley as required by law; and

WHEREAS, it appears further that said notices and publications were in all respects as required by the provisions of an act of the Legislature of the State of California entitled "Street Vacation Act of 1941" Division IX, Part 3, Chapter 1 and 2 of the Street and Highway Code; and

WHEREAS, a public hearing has been held on said proposed closings as so noticed and having heard all evidence offered by any interested persons, the City Council of the City of El Paso de Robles finds that the alley as described is unnecessary for present and prospective future public street purposes.

BE IT FURTHER RESOLVED, that the City Clerk of the City of El Paso de Robles cause a certified copy of this Resolution to be recorded in the office of the County Recorder of the County of San Luis Obispo, State of California.



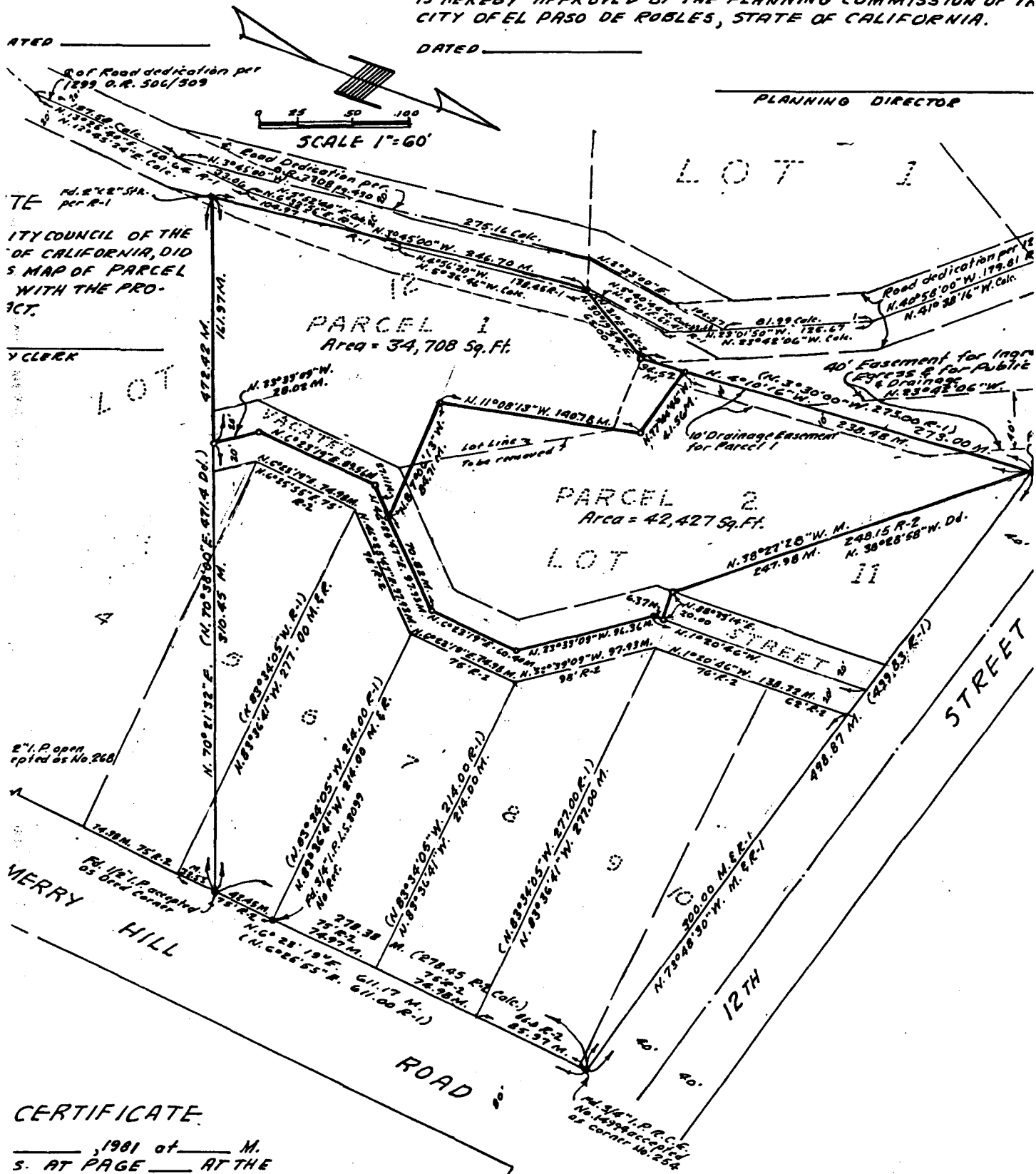
