The City Council of the City of El Paso de Robles hereby adopts a Sharp (Library) fund expenditure budget with the following understanding:


1. The Sharp fund expenditure budget is presented in this resolution without functional or line item detail. Detail appearing in the Exhibit are for informative purposes only.

- 2) Complete cleaning - \$150
 Our janitorial maintenance contract is at a minimal level. This request would allow for a thorough cleaning on a one time basis, and would include services not provided in the annual contract (such as dusting venetian blinds).


