

RESOLUTION NO. 2690

A RESOLUTION ACCEPTING CERTAIN PROPERTY FOR AN EASEMENT  
IN THE CITY OF EL PASO DE ROBLES

WHEREAS, the Council has received a Grant of Easement executed by John Johnson, Alan Hvolboll, and Leo A. Hanly, granting a strip of land along the north side of Paso Robles Boulevard over that portion of Lot 1 of Associated Almond Growers, Moorepark Tract, more particularly described as follows:

Beginning at the southwesterly corner of said Lot 1;  
Thence along the westerly line of said Lot 1, north 7° 49' 31" east, 26.03 feet to the beginning of a tangent curve, concave northeasterly, having a radius of 20.00 feet;  
Thence southeasterly along said curve through a central angle of 100° 23' 39", an arc distance of 35.04 feet;  
Thence tangent to said curve, north 87° 25' 52" east 105.42 feet;  
Thence easterly, along a tangent curve, concave northerly, having a radius of 1788.00 feet, through a central angle of 3° 13' 05", an arc distance of 100.42 feet;  
Thence tangent to said last mentioned curve, north 84° 12' 47" east 296.42 feet;  
Thence northeasterly along a tangent curve, concave northwesterly, having a radius of 726.80 feet, through a central angle of 20° 26' 30", an arc distance of 259.30 feet to the beginning of a compound curve, concave northwesterly, having a radius of 571.96 feet;  
Thence northeasterly along said compound curve, through a central angle of 12° 11' 07", an arc distance of 121.64 feet to the easterly line of said Lot 1;  
Thence along said easterly line, south 4° 04' 38" west 11.42 feet to the southeasterly corner of said Lot 1;  
Thence westerly along the southerly line of said Lot 1, following its various courses and curves to the point of beginning.

WHEREAS, said property is being acquired for road purposes and maintenance and construction of public utilities;

BE, AND IT IS HEREBY RESOLVED by the City of El Paso de Robles as follows:

That the Grant of Easement for said property is hereby accepted and the City of El Paso de Robles consents to recordation of said Easement by its duly authorized officer.
