

RESOLUTION NO. 2791

A RESOLUTION APPROVING ANNEXATION NO. 52
(CAFFREY)

WHEREAS, a proposal for annexation of the hereinafter described property has been filed; and

WHEREAS, the Local Agency Formation Commission by Resolution No. 82-18 approved Annexation No. 52 and has requested the following fees and documents for filing with the Secretary of State:

1. Eleven (11) certified copies of the resolution approving the boundary change.
2. Ten (10) copies of the legal description of boundaries approved by LAFCo.
3. Ten (10) copies of the map showing boundaries of the area approved by LAFCo.
4. The State Board of Equalization fee in the amount of \$220.00 must be received by the Deputy Executive Officer.
5. The City Manager must complete the Certificate Re: Terms and Conditions and Indebtedness and return it to the Deputy Executive Officer.

WHEREAS, maps and legal descriptions are attached hereto as Exhibit "A";
and

WHEREAS, a public hearing was held on November 16, 1982 at which all interested parties were heard.

NOW, THEREFORE, BE IT RESOLVED that the annexation of territory hereinafter described and designated "Annexation No. 52" is approved subject to said annexed area being taxed to pay its proportional share of the outstanding bonded indebtedness of the City of El Paso de Robles and the annexation fees as set forth in Resolution No. 2728.

RESOLVED FURTHER, that the City Clerk is directed to transmit eleven (11) certified copies of this resolution to the Executive Officer of the Local Agency Formation Commission together with fees required by Section 35220 of the Government Code of the State of California and any other attachments germane.


