A RESOLUTION AUTHORIZING EXECUTION OF QUITCLAIM DEED TO KAY AUSTIN MASSEY

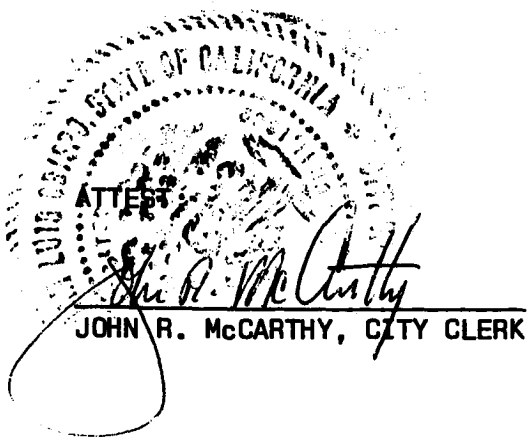

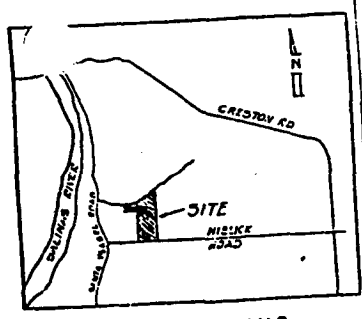
