

RESOLUTION NO. 2922

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES, CALIFORNIA,
RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD IN THE CITY ON
JUNE 5, 1984, DECLARING THE RESULT AND SUCH OTHER MATTERS
AS PROVIDED BY THE PROVISIONS OF LAW.

WHEREAS, a general municipal election was held and conducted in the City
of El Paso de Robles, California, on Tuesday, June 5, 1984, as required by law; and

WHEREAS, notice of the election was duly and regularly given in time, form and
manner as provided by law; that voting precincts were properly established; that
election officers were appointed and that in all respects the election was held
and conducted and the votes were cast, received and canvassed and the returns made
and declared in time, form and manner as required by the provisions of the Elections
Code of the State of California for the holding of elections in cities; and

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES, CALIFORNIA,
DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. That the names of persons voted for at the election for Member
of City Council of the City are as follows:

GARY E. STEMPER	BETTY COUSINS
ALAN GALLATIN	NICK RUSSELL
DALE I. GUSTIN	JOYCE M. LEW

That the name of the person voted for at the election for City
Clerk of the City is as follows:

JOHN R. MCCARTHY

That the name of the person voted for at the election for City
Treasurer is as follows:

SIDNEY J. GODSEY

SECTION 2. That the number of votes given at each precinct and the number of
votes given in the City to each of such persons above named for
the respective offices for which the persons were candidates were
as listed in Exhibit "A" attached.

SECTION 3: The City Clerk shall enter on the records of the City Council of
the City, a statement of the result of the election showing:

- (1) The whole number of votes cast in the City;
- (2) The names of the persons voted for;
- (3) For what office each person was voted for.


SECTION 4. That the City Clerk shall immediately make and deliver to each of such persons so elected a Certificate of Election signed by the City Clerk and duly authenticated; that the City Clerk shall also administer to each persons elected, the Oath of Office prescribed in the State Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.

SECTION 5. That the City Clerk shall certify to the passage and adoption of this Resolution and enter it into the book of original Resolutions.


