

RESOLUTION NO. 3060

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES, CALIFORNIA RECITING THE FACT OF THE CONSOLIDATED GENERAL DISTRICT ELECTION HELD IN THE CITY ON NOVEMBER 5, 1985, DECLARING THE RESULT AND SUCH OTHER MATTERS AS PROVIDED BY THE PROVISIONS OF LAW.

WHEREAS, a consolidated general district election was held and conducted in the City of El Paso de Robles, California on Tuesday, November 5, 1985, as required by law; and

WHEREAS, notice of the elction was duly and regularly given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in cities; and

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. That the issue voted upon at the election is as follows:

MEASURE "F" "Shall the Housing Authority of the City of Paso Robles, an independent public entity, be authorized to develop low-income housing specifically designed for elderly low-income residents, not to exceed 75 additional units."

SECTION 2. That the number of votes given at each precinct and the number of votes given in the City to "Measure F" were as listed in Exhibit "A" attached hereto.

SECTION 3. The City Clerk shall enter on the records of the City Council of the City, a statement of the result of the election showing:

- 1) The whole number of votes cast in the City;
- 2) The name of the issue voted upon.


SECTION 4. That the City Clerk shall certify to the passage and adoption of this Resolution and enter it into the book of original Resolutions.

PASSED, APPROVED AND ADOPTED on the 3rd day of December, 1985 by the following vote:


