RESOLUTION NO. 87-1

A RESOLUTION ACCEPTING A GRANT OF EASEMENT FOR STORM DRAIN MAINTENANCE PURPOSES FROM C AND M PROPERTIES, 6TH & SPRING IN THE CITY OF EL PASO DE ROBLES

WHEREAS, the Council has received a Grant of Easement from C and M Properties, a General Partnership of Ken Clousten Inc. and Harvey K. Munde granting a portion of Lots 11 and 12, Block 117 recorded in Book A of Maps, Page 169 and an abandoned portion of 5th Street as recorded in Volume 70, Page 338 of Official Records in the Office of the County Recorder of said County, which lies five (5) feet each side of a centerline described as follows:

Commencing at the northwest corner of Lot 12, Block 117, thence S 73 01' 35.6" E., 160.46 feet to a point on the easterly property line of Lot 11. Said point being 7.00 feet South of the North-east corner at Lot 11; and

WHEREAS, said property is being accepted for the purpose of storm drain maintenance.

The the Grant of Easement to said property is hereby accepted and the City of El Paso de Robles consents to recordation of said Easement by its duly authorized officer.

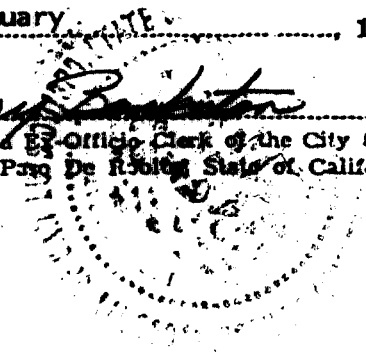

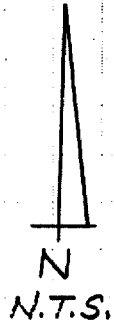

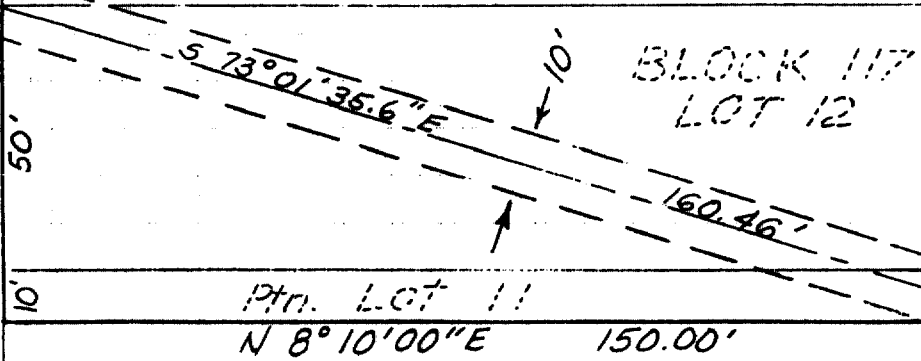
