RESOLUTION NO. 87-35

A RESOLUTION OF INTENTION FOR VACATING A PORTION OF NIBLICK ROAD IN THE CITY OF EL PASO DE ROBLES AND GIVING NOTICE OF TIME AND PLACE FOR A PUBLIC HEARING THEREON

The CITY COUNCIL of the CITY of EL PASO DE ROBLES does hereby resolve as follows:

1. That it is the intention of the City Council to close and vacate a public street in the City of El Paso de Robles, County of San Luis Obispo, State of California, and more particularly described as follows:

That portion of Niblick Road as shown in Book 29 of Parcel Maps at Page 43, in the office of the County Recorder of San Luis Obispo County, State of California.

Being more particularly described as follows:

Beginning at the most southeasterly corner of Parcel 1, as shown on said Parcel Map;

1. Thence south 75 degrees 04 minutes 09 seconds east, 244.17 feet;
2. Thence north 89 degrees 56 minutes 00 seconds west, 235.93 feet;
3. Thence north 0 degrees 00 minutes 44 seconds east, 62.63 feet to the point of beginning.

2. For further particulars as to the proposed vacation, reference is hereby made to a map now on file in the office of the City Clerk of the City of El Paso de Robles,

3. That Tuesday, JULY 7, _____, 1987, at the hour of 7:30 P.M. on said date in the City Council Chambers, City Hall, 1030 Spring Street, Paso Robles,

California, is the time and place set forth for hearing all persons interested in or having objections to the proposed closing.

4. That the City Clerk of the City of El Paso de Robles be and is hereby directed to cause a copy of this Resolution of Intention to be published fifteen (15) days prior to the date set herein for hearing in The Country News, a newspaper of general circulation, published and circulated in the City of El Paso de Robles, California.

5. The City Engineer of the City of El Paso de Robles be and is hereby directed to cause a notice of the passage of this Resolution of Intention and the time and place set for hearing thereon by conspicuously posting notices thereof along the line of the street proposed to be closed.
