RESOLUTION NO. 87-95

A RESOLUTION ESTABLISHING WATER RATES AND OTHER VARIOUS WATER UTILITY FEES

WHEREAS, Section 14.04.020 of the Municipal Code of the City of El Paso de Robles requires that the City Council, from time to time, with references to said section to set fees for monthly water service rates and other various service fees; and

WHEREAS, it is prudent to set the existing user charges for water used and services rendered to permit the Water Department to operate in a self sustaining manner; and

WHEREAS, it is determined that the following rates and fees shall be as follows:

1. For all fixed meter users the water rates to be charged by the City of El Paso de Robles to its water customers be at the following bi-monthly rates:

- a. The first 2,000 cubic feet or any fraction thereof, eighteen dollars and sixty cents (\$18.60).
- b. For all usage above 2,000 cubic feet, sixty-nine cents (\$0.69) per 100 cubic feet, or fraction thereof.
- c. That all accounts being served and located outside the City Limits be billed at twice the above rates.

The following fees shall be established for miscellaneous water utility services:

- a. The reinstatement fee for reinstating water service after its has been discontinued for non-payment shall be fifteen dollars (\$15.00).
- b. The fee for providing water service after hours and on weekends shall be thirty dollars (\$30.00).
- c. When a re-read is requested by a water utility customer, the fee for rereading a meter alleged been not read or misread shall be fifteen dollars (\$15.00). The fee shall not be charged if the meter reading is determined to have been inaccurate.
- d. When a field test is requested by a water utility customer, the fee for field testing a meter alleged to have been registering inaccurately shall be twenty-five dollars (\$25.00). The fee shall not be charged if the meter is determined to have been registering inaccurately.

- e. When a bench test is requested by a water utility customer, the fee for bench testing a meter alleged to have been registering inaccurately shall be fifty dollars (\$50.00). The fee shall not be charged if the meter is determined to have been registering inaccurately
- f. The fee for discontinuing service a second time after a meter lock has been cut, removed and/or damaged shall be set at fifty dollars (\$50.00).
- g. The fee for discontinuing service the second time after the meter couplers have been cut, removed and/or damaged should be set at seventy-five dollars (\$75.00).

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of El Paso de Robles that the above listed water service rates and fees be adopted and become effective January 1, 1988.
