WHEREAS, a public hearing was conducted by the Planning Commission on January 23, 1990 to consider facts as presented in the staff report prepared for this project and to accept public testimony regarding this project proposal, and

WHEREAS, the City Council held a public hearing on April 3, 1990 to consider the initial study prepared for this application, the staff report prepared for this project, and to accept public testimony regarding this proposed subdivision, and

WHEREAS, based on the mitigation measures identified and required within the resolution granting approval for Conditional Use Permit 89010, the City Council finds that the project will not have a significant effect in this case because mitigation measures have been included as requirements of project development.
