RESOLUTION NO. 90-59

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES APPROVING CITY OF PASO ROBLES' EXECUTION OF A JOINT POWERS AGREEMENT AMONG THE COUNTY OF SAN LUIS OBISPO AND THE CITIES OF ARROYO GRANDE, ATASCADERO, GROVER CITY, PASO ROBLES, MORRO BAY, PISMO BEACH, AND SAN LUIS OBISPO FOR THE PREPARATION OF A COUNTY AND CITIES' NOISE ELEMENT UPDATE; CONSTRUCTION STANDARDS; NOISE DESIGN MANUAL; AND NOISE ORDINANCE REVISIONS

WHEREAS, The existing Noise Element of the General Plan for the City of El Paso De Robles was prepared under a joint powers agreement with the County and other cities in the county; and

WHEREAS, The existing Noise Element of the General Plan for the City of El Paso De Robles was adopted on August 2, 1977, via Resolution No. 2151, and is in need of updating; and

WHEREAS, City, County and other cities in the county have determined that it is cost effective to prepare an update to the Noise Element under a joint powers agreement; and


WHEREAS, the City Attorney has reviewed the attached Joint Powers Agreement and approves of its form and content;

BE IT FURTHER RESOLVED that the City Clerk is directed to transmit a certified copy of this resolution and a check for \$4,869.51, corresponding to the City's share of the cost of preparing this update to the Noise Element, to the County of San Luis Obispo.
