A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PASO ROBLES, CALIFORNIA, RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD ON JUNE 5, 1990, DECLARING THE RESULT AND SUCH OTHERS MATTERS AS PROVIDED BY LAW

WHEREAS, a General Municipal Election was held and conducted in the City of El Paso de Robles, California, on Tuesday, June 5, 1990, as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

WHEREAS, pursuant to County Board of Supervisors action of June 26, 1990 the County Election Department canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part hereof as "Exhibit A".

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. That the whole number of votes cast in the City except absent voter ballots was 3527.

That the whole number of absent voter ballots cast in the City was 672, making a total of 4199 votes cast in the City.

SECTION 2. That the names of persons voted for at the election for Member of the City Council are as follows:

DICK CONWAY	CHRISTIAN E. IVERSEN
JERRY "COACH" CATHEY	DUANE PICANCO
JAMES N. HEGGARTY	DENNIS J. SMITH

SECTION 3. The City Council does declare and determine that Christian E. Iversen was elected as a Member of the City Council for the full term of four years and Duane Picanco was elected as a Member of the City Council for the full term of four years.

SECTION 4. The City Clerk shall enter on the records of the City Council of the City, a statement of the result of the election, showing: (1) The whole number of votes cast in the City; (2) The names of the persons voted for; (3) For what office each persons was voted for; (5) The number of votes given at each precinct to each person; and the total number of votes given to each person.

SECTION 5. That the City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated; that the City Clerk shall also administer to each persons elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Each and all of the persons so elected shall then be Clerk. inducted into the respective office to which they have been elected.

SECTION 6. That the City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.
