A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES, CALIFORNIA, AS ANNEXING PARCEL MAP PR 89-418 AS SUBAREA 7 TO THE "PASO/ROBLES LANDSCAPE AND LIGHTING DISTRICT NO. 1" (STREETS AND HIGHWAYS CODE SECTIONS 22500, ET SEQ.)

(WOODLAND PLAZA)

WHEREAS, pursuant to Resolution No. 90-112, the City Council has previously initiated proceedings and declared its intent to annex Parcels 1 thru 7 of Parcel Map PR 89-418 to Landcape and Lighting District No. 1 ("District"); and

WHEREAS, the owners of the real property have consented in writing to annexation into the District.

- 2. The current owner of the real property, according to the Petition for Formation of the District, is WOODLAND PLAZA ASSOCIATES.
- 3. The assessment for this fiscal year (1989-90) shall be zero.


