The south six feet and the east six feet of: That certain parcel of land in the City of El Paso de Robles, in the County of San Luis Obispo, State of California, according to the map thereof filed for record October 25, 1889 in Book A, Page 169 of Maps, in the office of the County Recorder of said County, described as follows: Beginning at the intersection of the Westerly line of Riverside Avenue with the easterly prolongation of the northerly line of 26th Street; thence westerly along said prolongation of 26th Street, 181.8 feet to easterly line of the right of way of the Southern Pacific Railroad right of way as said right of way is described in the deed to Southern Pacific Railroad Company recorded April 22, 1889 in Book 40, Page 194 of Deeds; thence north along the easterly line of said right of way, 160 feet; thence easterly parallel with the northerly line of 26th Street to the westerly line of Riverside Avenue; thence southerly along said west line to the point of beginning. 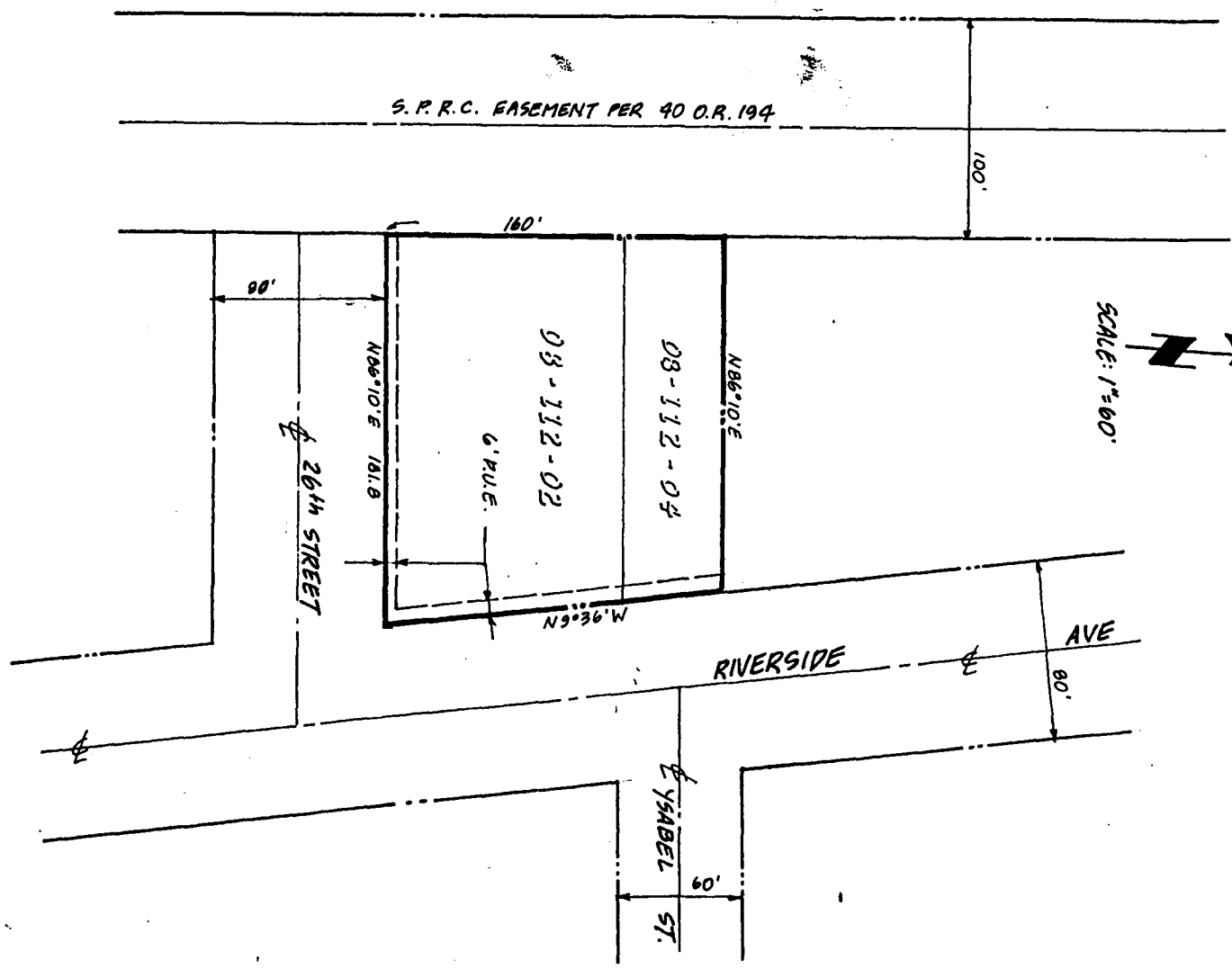
