A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PASO ROBLES ESTABLISHING A COMPENSATION PLAN AND RELATED EMPLOYEE BENEFITS FOR NON-REPRESENTED, PART-TIME/HOURLY CLASSIFICATIONS

WHEREAS, the Government Code of the State of California prescribes a procedure for resolving matters regarding wages, hours and other terms and conditions of employment; and

WHEREAS, City Code Section 2.40.030(c) provides for adoption of salary or compensation by resolution.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Paso Robles, as follows:

SECTION 1. TERM.

1

The term of the provisions of this Resolution shall be for not less than 12 months, commencing September 30, 1990, and thereafter shall continue until modified by another resolution.

SECTION 2. COMPENSATION PLAN.

A. Non-represented part-time/hourly employees, shall be assigned to Salary Ranges as presented in Appendix I. The range assignments reflect a 5.5% wage adjustment, effective the first full pay period in October 1990. In addition, the salary range assignments are consistent with and implement appropriate equity adjustments to unit classifications.

SECTION 3. BENEFITS.

A. All benefits previously approved shall continue and be applied equally to all regular part-time/hourly personnel covered by this resolution. Seasonal and temporary part-time/hourly personnel are not eligible for benefits other than those provided by Federal or State statutes.
