A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES ORDERING TERRITORY DESIGNATED AS "ANNEXATION NO, 67 (ERSKINE) TO BE ANNEXED TO THE CITY OF EL PASO DE ROBLES

WHEREAS, Tom Erskine has initiated an annexation of approximately 12.6 acres known as the "Erskine Annexation" described by the map attached hereto as Exhibit A and Legal Description attached hereto as Exhibit B; and

WHEREAS, The Local Agency Formation Commission (LAFCD) by Resolution 90-24, adopted October 18, 1990, approved Annexation No. 67 and has requested the following fees and documents for filing with the Secretary of State:

1. Six (6) certified copies of the resolution approving the boundary change;

2. Six (6) copies of the Legal Description of the boundaries approved by LAFCO;

3. Six (6) copies of the map showing boundaries of the areas approved by LAFCO;

4. The State Board of Equalization fee in the amount of \$180.00 made payable to the "State Board of Equalization"; and

WHEREAS, The purposes for this annexation are: to enable the provision of City water and sewer services; to eliminate a "pocket" of land under County jurisdiction; and to improve the efficiency of emergency and street maintenance services; and

WHEREAS, There are no terms and conditions attached to this annexation; and

WHEREAS, the regular county assessment roll is utilized by this City; and

WHEREAS, The affected territory will be taxed for existing bonded indebtedness of this City; and

WHEREAS, A public hearing on this annexation was called for and held by this Council on November 20, 1990, and this Council finds and determines that the value of written protests filed and not withdrawn represents both the number of owners of land owning less than 50 percent of the assessed value of land within the area to be annexed.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of El Paso de Robles, that the annexation of territory hereinafter described and designated as "Annexation No. 67" is ordered

subject to said annexed area being taxed to pay its proportional share of the outstanding bonded indebtedness of the City of El Paso de Robles.


