## **RESOLUTION NO.**91-06\_\_\_\_

## A RESOLUTION CLOSING A PUBLIC UTILITY EASEMENT (PORTION OF 8TH STREET, LYING EAST OF PASO ROBLES STREET) IN THE CITY OF EL PASO DE ROBLES

WHEREAS, the City Council of the City of Paso Robles, having on the <u>4th</u> day of <u>December</u>, 19<u>90</u>, passed a Resolution of Intention to close and vacate a portion of a public utility easement in the City of Paso Robles, County of San Luis Obispo, State of California, which is more particularly described as follows:

The southerly forty feet (40') of a public utility easement located in the vacated portion of 8th Street lying east of Paso Robles Street as recorded in Volume 2122, Page 573 of Official Records.

WHEREAS, it now appears that the City Clerk of the City of Paso Robles did cause said Resolution of Intention to be published in the Paso Robles Country News as required by law; and

WHEREAS, it further appears that said notices and publications were in all respects as required by the provisions of an act of the Legislature of the State of California entitled "Street Vacation Act of 1941", Division IX, Part 3, Chapters 1 and 2 of the Streets and Highways Code; and

WHEREAS, a public hearing has been held on said proposed closing as so noticed and having heard all evidence offered by any person interested, the City Council of the City of Paso Robles finds that the easement as described is unnecessary for present or prospective future public utility purposes.

## NOW THEREFORE BE IT RESOLVED AS FOLLOWS:

1. That the public utility easement cease on said easement hereinbefore described and be vacated for public utility purposes.

2. That the City of Paso Robles does hereby reserve and except from said vacation a permanent public utility easement and right, at any time or from time to time, for the purpose of constructing, maintaining, operating, replacing, removing and renewing all public utilities and appurtenant structures in, over,

under, and across the northerly ten feet (10') of the vacated area hereinabove described with ingress and egress rights for said purposes including access for the protection of said facilities from all hazards.

3. That the City Clerk of the City of Paso Robles cause a certified copy of this Resolution to be recorded in the office of the Country Recorder of San Luis Obispo County, State of California.


