RESOLUTION NO. 91- 68

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES ORDERING TERRITORY DESIGNATED AS "ANNEXATION NO. 70 (CEMETERY) TO BE ANNEXED TO THE CITY OF EL PASO DE ROBLES

WHEREAS, The Paso Robles Cemetery District has initiated an annexation of approximately 1.5 acres known as the "Cemetery Annexation" described by the map attached hereto as Exhibit A and Legal Description attached hereto as Exhibit B; and

WHEREAS, The Local Agency Formation Commission (LAFCO) by Resolution 91-1, adopted April 18, 1991, approved Annexation No. 70 and has requested the following fees and documents for filing with the Secretary of State:

1. Six (6) certified copies of the resolution approving the boundary change;

2. Six (6) copies of the Legal Description of the boundaries approved by LAFCO;

3. Six (6) copies of the map showing boundaries of the areas approved by LAFCO;

4. The State Board of Equalization fee in the amount of \$160.00 made payable to the "State Board of Equalization"; and

WHEREAS, The purpose for this annexation is to facilitate the reconstruction of the intersection of Nacimiento Lake Drive and Mountain Springs Road; and

WHEREAS, There are no terms and conditions attached to this annexation; and

WHEREAS, the regular county assessment roll is utilized by this City; and

WHEREAS, The affected territory will be taxed for existing bonded indebtedness of this City; and

WHEREAS, A public hearing on this annexation was called for and held by this Council on May 21, 1991, and this Council finds and determines that the value of written protests filed and not withdrawn represents both the number of owners of land owning less than 50 percent of the assessed value of land within the area to be annexed.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of El Paso de Robles, that the annexation of territory hereinafter described and designated as "Annexation No. 70" is ordered subject to said annexed area being taxed to pay its proportional

share of the outstanding bonded indebtedness of the City of El Paso de Robles.

BE IT FURTHER RESOLVED that the City Clerk is directed to transmit six (6) copies of this resolution to the Executive Officer of the Local Agency Formation Commission together with the fees required by Section 54902.5 of the Government Code of the State of California and any other attachments germane.


