

RESOLUTION NO. 91-49

A RESOLUTION OF THE CITY COUNCIL  
OF THE CITY OF EL PASO DE ROBLES  
APPROVING A BUDGETARY APPROPRIATION  
AND AUTHORIZING A BID AWARD FOR THE  
PURCHASE OF TRANSIT BUS.

WHEREAS, the City Council has previously given approval to distribute bid specifications for the purchase of a new transit bus; and

WHEREAS, the City Council is desirous of awarding the purchase of a new transit bus to the lowest responsive bidder; and

WHEREAS, the City Council has also previously authorized a budgetary appropriation for the purchase of a transit bus; and

WHEREAS, the original budgetary appropriation is \$6,700 less than the bid made by the lowest responsive bidder.

BE IT HEREBY RESOLVED that an additional budgetary appropriation in the amount of \$6,700 is authorized from the TDA Fund to budget account no. 206-145-5454-000; and


BE IT FURTHER RESOLVED that the purchase of a sixteen (16) passenger, one (1) wheelchair capacity transit bus is hereby awarded to the lowest responsive bidder, A-Z Bus Sales.
