of California.

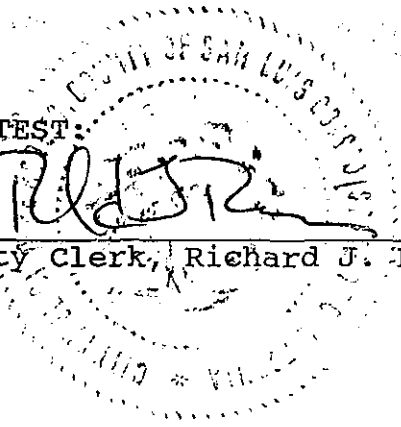

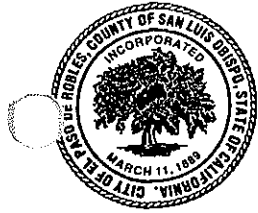
