

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PASO ROBLES APPROVING APPROPRIATION OF \$5,000 FROM GENERAL FUND TO CITY MANAGER'S OFFICE, HUMAN RESOURCES; LABOR, SALARY, AND BENEFITS PROGRAM BUDGET FOR IMPLEMENTATION OF OMNIBUS TRANSPORTATION EMPLOYEE TESTING ACT OF 1991**

WHEREAS, in February, 1994, the U.S. Department of Transportation (DOT) issued final regulations implementing the Omnibus Transportation Act of 1991; and

WHEREAS, said regulations require employers to test transportation safety sensitive employees for the use of alcohol and controlled substances; and

WHEREAS, The regulations will become effective January 1, 1996, and will require cities to:

1. implement mandatory random drug and alcohol testing procedures for affected workers;
2. provide notice of testing to employees;
3. maintain records regarding the testing procedures and results;
4. fund the program -- no funds have been provided for implementation of these regulations.

WHEREAS, The Central Coast Cities Self Insurance Fund Joint Powers Authority, of which the City is a member, has arranged a service agreement with Addiction Medicine Consultants, Inc. (AMC) for DOT mandated drug and alcohol testing and policy & program development.

WHEREAS, The AMC service is offered through the JPA at a cost of \$50 per covered worker annually.

WHEREAS, The AMC service is offered through the JPA at a cost of \$50 per covered worker annually.

WHEREAS, City workers subject to random drug and alcohol testing are those required to possess California Motor Vehicle Operator's license to operate: a) a vehicle with gross weight of 26,001 lbs; b) a vehicle designed to transport 16 or more persons; or c) a vehicle used to transport hazardous materials found in the Hazardous Materials Act. Typically, this would include, but would not necessarily be limited to: utility vehicle drivers, mechanics, water utility workers and supervisors, street maintenance equipment operators, street sweepers, municipal bus drivers, dispatchers, hazardous materials transport operators, fire truck operators. Total number of covered workers equals 40, plus 45 fire volunteers.

**THEREFORE, BE IT RESOLVED AS FOLLOWS:**

That the City Council of the City of Paso Robles does appropriate \$5,000.00 from the General Fund Reserves to Account Number 100-130-5212-116 "Labor, Salary & Benefit Administration".
