

RESOLUTION NO. 96-48

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES, CALIFORNIA, INITIATING PROCEEDINGS FOR THE ANNUAL LEVY OF ASSESSMENTS FOR THE EL PASO DE ROBLES LANDSCAPE AND LIGHTING MAINTENANCE ASSESSMENT DISTRICT NO. 1, FISCAL YEAR 1996/1997.

The City Council of the City of El Paso de Robles, California does resolve as follows:

WHEREAS, The City Council of the City of El Paso de Robles, California, has, by previous Resolutions, formed the El Paso de Robles Landscape and Lighting Maintenance Assessment District No. 1 (herein after referred to as the "District") pursuant to the provisions of the *Landscaping and Lighting Act of 1972, Part 2 of Division 15 of the Streets and Highways Code of California, beginning with Section 22500* (hereinafter referred to as the "Act"), that provides for levy and collection of assessments by the County of San Luis Obispo for the City of El Paso de Robles to pay for the maintenance and services of street lighting, landscaping, and all appurtenant facilities and operations related thereto.

WHEREAS, the City Council has retained MuniFinancial, Inc., for the purpose of assisting with the Annual Levy of the District, and to prepare and file a report with the City Clerk in accordance with the Act;

NOW, THEREFORE, BE IT RESOLVED, DETERMINED, AND ORDERED BY THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES, CALIFORNIA, FOR EL PASO DE ROBLES LANDSCAPE AND LIGHTING MAINTENANCE ASSESSMENT DISTRICT NO. 1, AS FOLLOWS:

Section 1 Annual Levy Report: The City Council hereby orders MuniFinancial, Inc. to prepare the Annual Levy Report concerning the levy of assessments for the District in accordance with *Chapter 3, Section 22622* of the Act.

Section 2 Proposed improvements and any substantial changes in existing improvements: The improvements within the District include: turf, ground cover, shrubs and trees, irrigation systems, drainage systems, open space areas, public pedestrian paths, entry monuments, fencing, lighting systems and all necessary appurtenances. By previous Resolutions, during Fiscal Year 1995/96, the City Council annexed into the District, Sub Areas (19) Tract 1463-2, Union; and (21) Tract 1754-1, Eagle Creek. In addition, 105 parcels were annexed into Sub Area 2. Fiscal Year 1996/97 is the first year of assessment for these areas. The Annual Levy Report describes all new improvements or substantial changes in existing improvements.
