**RESOLUTION NO. 96-126**

**A RESOLUTION OF THE CITY COUNCIL OF THE  
CITY OF EL PASO DE ROBLES, CALIFORNIA, ANNEXING  
TRACT 1718 (D. PAUL WILSON) AS SUBAREA 28 TO  
THE "PASO ROBLES LANDSCAPE AND LIGHTING DISTRICT NO. 1"  
(STREETS AND HIGHWAYS CODE SECTIONS 22500, ET SEQ.)**

WHEREAS, pursuant to Resolution No. 92-24, adopted February 4, 1992, the owners of the real property have consented in writing to annexation into the District.

NOW, THEREFORE, the City Council of the City of El Paso de Robles, California, does resolve as follows:

1. It is hereby declared that the real property located in the City of El Paso de Robles, County of San Luis Obispo, which per Condition No. 30 of Resolution No. 92-24 granting tentative approval for Tract 1718, includes street lights, graffiti abatement, slope maintenance adjacent to the bike path along lot 8, 9, & 10; and being more particularly described in Exhibit "A" hereto, is hereby annexed to the Paso Robles Landscape and Lighting District No. 1 and that all maintenance of this area required as a condition of approval of TRACT 1718 be performed by the developer.

2. The current owners of the real property, according to the Petition for Formation of the District, is D. Paul Wilson and Marie Ann Wilson.

3. The assessment for this fiscal year (1996-97) shall be zero.

4. The area annexed shall be designated Paso Robles Landscape and Lighting District No. 1, Subarea 28.
