RESOLUTION NO. 97-78

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PASO ROBLES, CALIFORNIA, DECLARING THE RESULTS OF A PROPERTY OWNER PROTEST PROCEEDING AND APPROVING CERTAIN RELATED ACTIONS**

WHEREAS, the City Council of the City of Paso Robles, California (hereafter referred to as the "City Council") called and duly held a property owner protest proceeding in the El Paso de Robles Landscape and Lighting Maintenance District No. 1 (hereafter referred to as the "District") for the purpose of presenting to the qualified property owners within the newly annexed SubAreas within the District a proposition for the levy of assessments and an assessment range formula for the costs and expenses of the landscape improvements within; and,

WHEREAS, the results of the tabulation of the protest ballots by landowners of record within the newly annexed territory of the District as of the close of the Public Hearing held on June 3, 1997 were as follows: SubArea 21, no protest ballots were submitted to the City Clerk; SubArea 28, both property owners voted Yes; SubArea 29, the property owner voted No; SubArea 31, no protest ballots were submitted to the City Clerk; and,

WHEREAS, the property owners within SubArea 21, SubArea 28 and Sub Area 31 have consented to the levy of assessments and the assessment range formula; and,

**NOW, THEREFORE, THE CITY COUNCIL DOES HEREBY RESOLVE, ORDER AND DETERMINE:**

**Section 1** The above recitals are true and correct.

**Section 2** The canvass of the votes cast in the District at the property owner protest proceeding held in the District on June 3, 1997, is hereby approved and confirmed.

**Section 3** The proposition, presented to qualified property owners of the District for receipt by the City Clerk on June 3, 1997, each has received a vote of the qualified property owners voting at said property owner protest proceeding, and the proposition has carried. The City Council is hereby authorized to take the necessary steps to levy the assessments as authorized by the proposition.


**Section 4** The City Clerk is hereby directed to enter this Resolution on the minutes of the City Council which shall constitute the official declaration of the result of such property owner protest proceeding.


**Section 5** This Resolution shall become effective immediately upon its adoption.
