

RESOLUTION NO. 12-135

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PASO ROBLES
ESTABLISHING NEW FIELD RENTAL FEES FOR YOUTH SPORTS LEAGUES

WHEREAS, the Paso Robles Youth Sports Council (PRYSC) operates as a nonprofit board consisting of representatives from Paso Robles youth sports leagues, and;

WHEREAS, in 2006, City Council established baseline fees of \$7,500 for up to 3660 hours of field reservations for youth sports leagues participating in PRYSC, and;

WHEREAS, on May 1, 2012, City Council recommended that an ad hoc committee be formed to review the baseline field rental fees in light of significant and consistent increases in field use beyond the 3660 baseline hours by youth sports leagues participating in PRYSC, and;

WHEREAS, on July 12, 2012 the ad hoc committee reviewed a proposal submitted by PRYSC which: a) requested a new rate of \$10,000 annually for up to 6,000 hours of field reservations, b) pledged to provide labor and materials for the preparation and occasional maintenance of City youth sports facilities and c) requested a credit of \$4,000—funds paid for 2011 reservation overages—to PRSYC's 2012 reservation fees, and;

WHEREAS, ad hoc committee members agreed that PRYSC reservations exceeding 6,000 hours will be charged at \$3.00 per hour, in addition to the \$10,000 baseline rate.

WHEREAS, Youth sports leagues that are not members of PRYSC shall continue to be charged a flat fee of \$3.00 per hour.

THEREFORE BE IT HEREBY RESOLVED by the City Council of the City of El Paso de Robles, to adopt Resolution No. 12-135, implementing:

- A new baseline fee of \$10,000 per year for up to 6,000 hours of field use, effective January 1, 2012, due and payable annually on December 1 commencing December 1, 2012.
- An additional charge of \$3.00 per hour for use exceeding 6,000 hours in a calendar year.
- A credit of \$4,000, the amount paid for 2011 field rental overages, to PRYSC's 2012 fees.
- Renegotiation of field rental fees for the 2014 calendar year.
