A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PASO ROBLES AWARDING A CONTRACT FOR THE REMOVAL OF AVIATION FUEL TANKS AT THE MUNICIPAL AIRPORT AND APPROPRIATING FUNDING FROM AIRPORT RESERVES

WHEREAS, the City of Paso Robles operates and maintains its Municipal Airport for the service and benefit of the flying public; and

WHEREAS, the City of Paso Robles has determined that the existing airport fuel service facility is now non-compliant, obsolete and must be removed; and

WHEREAS, the City of Paso Robles, in conformance to adopted purchasing policy did request and received price quotations for the required work.

NOW, THEREFORE BE IT RESOLVED that the City Council of the City of Paso Robles:

1. Authorizes the award and execution of a construction contract for the removal of the airport fuel facility as specified, with SA Recycling, LLC in the amount of \$23,925.00.
2. Authorizes the appropriation of funds from Airport Reserves (#602) in that amount.
3. Authorizes execution of the associated contract documents, as required.
