

RESOLUTION NO. 15-029

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PASO ROBLES
ALLOCATING GENERAL FUND RESERVES
FOR THE REPAIR OF ILLUMINATED STREET NAME SIGNS

WHEREAS, the Streets Maintenance Division staff has identified 58 of a total of 69 illuminated street name signs at traffic signals as non-operational; and

WHEREAS, illuminated street name signs improve sign visibility and legibility at all distances and in all conditions; and

WHEREAS, the Street Lighting, Traffic Signal, Road Marking and Signage budget is estimated to be 100% spent this fiscal year; and

WHEREAS, staff requests that City Council allocate \$25,000 from General Fund Reserves for repairs to all inoperable illuminated street name signs.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

SECTION 1. The City Council of the City of El Paso de Robles does hereby allocate \$25,000 from General Fund Reserves to the Streets Division Maintenance and Operations Budget No. 1003305-52227 for illuminated street sign repair.


