A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES  
RE-DESIGNATING STAFF TO REPRESENT THE CITY OF PASO ROBLES ON THE SAN LUIS OBISPO  
COUNTY PASO ROBLES GROUNDWATER BASIN ADVISORY COMMITTEE

WHEREAS, the San Luis Obispo County Board of Supervisors created the Paso Robles Groundwater Basin Advisory Committee for the purpose of providing a forum for stakeholder involvement in basin management efforts and to advise the Board of Supervisors on matter related to the management of the Paso Robles Groundwater Basin.

WHEREAS, the City of Paso Robles has been designated as having a seat on the advisory committee.

WHEREAS, as an advisory committee to the Board of Supervisors, the Maddy Act requires that agencies having a seat on the committee designate a primary committee member and an alternate member through a Board or Council action.

WHEREAS, on April 1, 2014, the Paso Robles City Council adopted Resolution No. 14-038, designating Christopher Alakel and Christine Halley with T.J. Cross Engineers, as the primary and alternate members to the Paso Robles Groundwater Basin Advisory Committee.

WHEREAS, due to new staffing the re-designation of representation for the Paso Robles Groundwater Basin Advisory Committee shall be the Director of Public Works as the primary and Christopher Alakel the alternate

THEREFORE, BE IT RESOLVED AS FOLLOWS:

SECTION 1. The City Council of the City of Paso Robles does designate Richard McKinley, Director of Public Works, as the primary committee member and Christopher Alakel, Water Resources Manager, as the alternate member of the San Luis Obispo County Paso Robles Groundwater Basin Advisory Committee.



**Paso Robles Groundwater Basin Advisory Committee**

**Purpose**

The purpose of the Paso Robles Groundwater Basin (Basin) Advisory Committee (Committee) is to advise the Board of Supervisors (BOS), acting either as the San Luis Obispo County Flood Control and Water Conservation District or San Luis Obispo County, concerning policy decisions relating to:

1. Implementation of the Basin Groundwater Management Plan
2. Development of a “enhanced” Groundwater Management Plan for the Basin
3. Formation of a new water district
4. Transition of an initial County-supported district to an independent district
5. Other policies and ordinances

The Committee will also serve as a public forum to discuss and collect comments on Basin issues.

**Structure**

This committee will be an official advisory committee to the BOS. The BOS will approve committee structure, solicit qualified applicants in accordance with Maddy Act requirements and will approve committee members.

**Time Frame**

This committee will sunset after a period of two years, however the BOS has the option to extend the time frame as needed.
