

SUBJECT:	TIME EXTENSION FOR TENTATIVE PARCEL MAP PR 04-0428 (WOODWARD & JUDIE DIKE)
DATE:	OCTOBER 24, 2006
Needs:	For the Planning Commission to consider the applicant's request for a one-year time extension of PR 04-0428, a tentative map to create two residential parcels.
Facts:	1. The R2 zoned site is located at 411 Oak Street.
	2. The project was initially approved on September 14, 2004, via Planning Commission resolution 04-110, and was scheduled to expire on September 14, 2006.
	3. A request for a time extension was filed before the September 14, 2006 deadline, automatically extending the life of the tentative tract map for an additional 60 days.
	4. There have been no changes in the General Plan/Zoning Land Use policies or standards applicable to approved development.
	5. Under the State's Subdivision Map Act the applicant is entitled to request up to three one-year time extensions.
	6. This is the applicant's first request for a time extension. If a one-year time extension were granted, the applicant would still be entitled to request two more extensions not to exceed a period of one year each.
Analysis	
and Conclusion:	Staff has reviewed the time extension request and has identified no additional changes are necessary. All existing project conditions would remain in effect.
Policy Reference:	General Plan Land Use Element, Zoning Code.
Fiscal Impact:	There are no specific fiscal impacts associated with approval of this time extension.

- Options: After consideration of public testimony, the Planning Commission should consider one of the following options:
  - a. Adopt a resolution granting a one-year time extension for Tentative Parcel Map PR 04-0428;
  - b. Adopt a resolution granting a time extension for a shorter period of time;
  - c. Amend, modify or reject the above noted options.

WHEREAS, on October 12, 2004 the Planning Commission adopted Resolution 04-116 granting tentative parcel map approval to PR 03-342 for the subdivision of two parcels totaling 19,538 square feet into four parcels ranging in size from 3,247 to 9,742; and

WHEREAS, the subdivision is located at 2925 Oak Street; and

WHEREAS, under the provisions of the State's Subdivision Map Act the map approval was granted for a two (2) year period of time from the date of Planning Commission action; and

WHEREAS, the Planning Commission is empowered through the Zoning Code to approve tentative parcel maps and their related time extension requests; and

WHEREAS, the map was scheduled to expire on October 12, 2006; and

WHEREAS, on August 8, 2006, the applicant filed a request for a one year time extension of the subject tentative parcel map; and

WHEREAS, a public hearing was conducted by the Planning Commission on October 24, 2006, to consider facts as presented in the staff report prepared for this time extension and to accept public testimony regarding the extension; and

NOW, THEREFORE, BE IT RESOLVED, that the Planning Commission of the City of El Paso de Robles does hereby grant a one year time extension (as measured from the most current expiration date of October 12, 2006) to Tentative Parcel Map 03-342, subject to the following condition:

- 1. All conditions adopted within Resolutions 04-116 shall remain in full force and effect (on file in the Community Development Department).
- 2. The Parcel Map will expire on October 12, 2007, unless a request for a time extension is filed prior to this date.
