Needs: For the Planning Commission to consider the applicant's request to develop a new wireless communication facility located at the Paso Robles High School, 801

Niblick Road.

Facts: 1. The proposed facility would consist of 3 panel antennas on an existing 80' sport light/monopole and an equipment cabinet on a proposed concrete slab.

2. The existing sport light/monopole is located in the vicinity of the baseball fields (see vicinity map).

- 3. The property is zoned R1 (Single Family Residential) and the General Plan designation is PF (Public Facilities).
- 4. Section 21.16.200 of the Municipal Code requires approval of a Conditional Use Permit for transmission and receiving stations in the R1 zoning district.
- 5. Ordinance No. 934 amended the zoning code to allow cellular facilities in the R1 zoning district. The ordinance requires that cellular facilities be associated with public or quasi-public facilities such as schools and be camouflaged so that they are not noticeable from the street.
- 6. The 80' tall monopole is in the vicinity of the other baseball field lights and appears similar to the other light standards. The existing light poles at the high school vary in height from 75' to around 90' tall.
- 7. The Planning Division staff has determined that this application is Categorically Exempt from environmental review per Section 15301 of the State's Guidelines to Implement CEQA. Section 15301 exempts existing facilities and the equipment would be installed on a preexisting monopole.

8. The Development Review Committee (DRC) reviewed this project at its meeting of September 17, 2007, Based on the proposed facility only having 3 panel antennas and being located on an existing sports light pole the Committee recommended that the Planning Commission approve the request.

Analysis and

Conclusions:

New telecommunication facilities in the City are required to be camouflaged. In this case the sports light standard will appear similar to other lights and will "blend in." However, as can be seen from the photo-simulations (attached) the antennas will be visible. Given the remoteness of the site and the fact that there are tall sports lights in the area of the modified light pole will appear to blend in with the other tall light poles in the vicinity.

This telecommunication facility would be similar to Condition Use Permit 07-012 recently approved by the Planning Commission for Verizon on August 28, 2007 to install a sports light pole with cellular antennas in the vicinity of the same baseball field. The equipment cabinet and the fencing are also compatible with other buildings and fences in this area of the school.


After consideration of any public testimony, the Planning Commission should consider the following options:




## **VICINITY MAP**

### A RESOLUTION OF THE PLANNING COMMISSION OF THE CITY OF EL PASO DE ROBLES TO APPROVE CONDITIONAL USE PERMIT 07-007 (CLEARWIRE)

APN: 009-611-045

WHEREAS, section 21.16.200 of the Municipal Code of the City of El Paso de Robles requires approval of a Conditional Use Permit for transmission and receiving stations in the R1 zoning district; and

WHEREAS, the applicant, Clearwire, has filed a Conditional Use Permit application to construct a wireless communication facility as a sports light standard located at 801 Niblick Road; and

WHEREAS, the school installation meets the Zoning Regulations requiring that the site be public or quasi-public; and

WHEREAS, the facility will have a camouflaged design, consisting of an existing 80'-tall sport light/monopole blending with other similarly designed poles at the school; and

WHEREAS, separate equipment would be located inside of an equipment cabinet on a proposed concrete slab; and

WHEREAS, and since the antennas will be attached to a sports field light pole and blend with other similar "utility structures," the project would be consistent with Land Use Element Policy 2B, relating to visual identity, including utility infrastructure; and

WHEREAS, a public hearing was conducted by the Planning Commission on October 9, 2007, to consider the facts as presented in the staff report prepared for this project, and to accept public testimony regarding this conditional use permit request; and

WHEREAS, based upon the facts and analysis presented in the staff report and public testimony received and subject to the conditions of approval listed below, the Planning Commission finds that the establishment, maintenance and operation for the requested use and building would be consistent with the General Plan and not be detrimental to the health, safety, morals, comfort, convenience and general welfare of the persons residing or working in the neighborhood of such proposed use, or be injurious or detrimental to property and improvements in the neighborhood or to the general welfare of the City.

NOW, THEREFORE, BE IT RESOLVED, that the Planning Commission of the City of El Paso de Robles does hereby approve Conditional Use Permit 07-007 subject to the following conditions:

1. The project shall be constructed so as to substantially conform to the following listed exhibits and conditions established by this resolution:

- 2. This Conditional Use Permit (CUP) authorizes the construction of a wireless communication facility at 801 Niblick Road, where the antenna panels would be attached to an existing 80'-tall sport light pole, in a manner described in attached exhibits.
- 3. This project approval shall expire on October 9, 2009, unless a building permit is issued for the project, or unless a time extension request is filed with the Community Development Department prior to expiration.
- 4. The site shall be developed and maintained in accordance with the approved plans and unless specifically provided for through the Conditional Use Permit process shall not waive compliance with any sections of the Zoning Code, all other applicable City Ordinances, and applicable Specific Plans.
- 5. Prior to occupancy, all conditions of approval shall be completed to the satisfaction of the City Engineer and Community Developer Director or his designee.
- 6. Any site specific condition imposed by the Planning Commission in approving this project may be modified or eliminated, or new conditions may be added, provided that the Planning Commission shall first conduct a public hearing in the same manner as required for the approval of this project. No such modification shall be made unless the Commission finds that such modification is necessary to protect the public interest and/or neighboring properties, or, in the case of deletion of an existing condition, that such action is necessary to permit reasonable operation and use for this approval.




CUP 07-007 Site, Equipment, and Antenna Layouts





Exhibit C CUP 07-007 Elevations



CUP 07-007 Lease Area Detail, Site/Boundary Plans




Exhibit E CUP 07-007 Boundary Plan
