SUBJECT: TENTATIVE TRACT MAP 2980 AND RIGHT-OF-WAY ABANDONMENT GOLDEN HILL ROAD AND HIGHWAY 46 (APN 025-391-037, 038, 039, 063 AND 067), APPLICANT – REGENCY CENTERS

DATE: JULY 22, 2008

Needs: For the Planning Commission to open and continue the public hearing on this project for Tentative Tract Map 2980 and Right-of-Way Abandonment request to the meeting on August 12, 2008.

- Facts:**
1. This item was previously continued from the meeting on July 8, 2008 to this meeting. However, there are still items related to the project that need more time to finalize.
 2. Staff requests the Planning Commission to continue consideration of this application until August 12, 2008.
 3. The project site was approved for a regional shopping center last August 2007.
 4. The applicant has been diligently working on processing site and building plans since the entitlement was approved.
 5. The applicant applied for a tract map to create 12 parcels for individual ownership of the buildings/units. They have also applied to have the public right-of-way easement abandoned, which currently extends from Golden Hill Road at the main site entrance into the site about 750 feet.


Options: After considering the information presented and the public testimony received, the Planning Commission will be asked to select one of the following options:

- a. Continue the open public hearing to the Planning Commission meeting on August 12, 2008.
- b. Amend, modify, or reject the above option.



NOTICE IS HEREBY GIVEN that the Planning Commission of the City of El Paso de Robles will hold a Public Hearing on Tuesday, July 8, 2008, at 7:30 p.m. at the City of El Paso de Robles, 1000 Spring Street, Paso Robles, California, in the City Council Chambers, to consider the following projects:

1. Amendment to Planned Development 06-025: A request filed by Regency Centers to modify Conditions of Approval previously approved for a regional shopping center to be located north of Highway 46 East and Golden Hill Road which includes a 169,112 s.f home improvement and garden center, and several other retail buildings with a combined building square footage of approximately 105,000 s.f., and three restaurant pads. (APNs 025-391-037, -033, -039, -063, and -067).
2. Tract 2980 and Public Right-of-Way Abandonment: A request filed by Regency Centers located north of Highway 46 East and Golden Hill Road, to subdivide the property into 11 commercial parcels and abandon an existing public Right-of-Way that extends from Golden Hill Road onto the project site.
