Needs: For the Planning Commission to consider the applicant's request for a one-year

time extension of Planned Development 04-015.

Facts: 1. The project is located at 1500 Ramada Drive (see attached location map).

2. PD 04-015 was approved by the Planning Commission on October 26, 2004, approving the construction of two approximate 20,000 square foot light-industrial buildings. The original entitlement was scheduled to expire on October 26, 2006.

- 3. An application for a one-year time extension was approved by the Planning Commission on December 12, 2006 extending the project entitlements to October 26, 2007 and again on November 13, 2007 further extending the entitlements to October 26, 2007.
- 4. A request for a time extension was filed before the October 26, 2007 deadline, automatically extending the entitlement for the project for 60 days.

Analysis and

Conclusion: Staff has reviewed the time extension request and has identified no additional

changes are necessary. There have been no changes in the General Plan or Zoning Regulations since the original approval in 2004 that would impact the prior approvals of this project or the conditions that were imposed with it.

extension.


Options:
